Perkins Capital Management, Inc. disclaims beneficial ownership in The Perkins Opportunity Fund shares.
- (b) The percent of class is 35.7%. This includes a percentage of 23.9% by clients of Perkins Capital Management, Inc. and 11.8% by the Perkins Opportunity Fund.
